

AGREEMENT
on industrial practice of students

Educational institution of higher professional education "Scientific Research Medical and Social Institute," hereinafter referred to as the institute, represented by Rector Tampagarov Kushtarbek Bekmuratovich, on the one hand and **Bashir Clinic** hereinafter referred to as the Organization, represented by Director Muhammad Rizwan Consultant Physician on the other hand, have entered into this agreement as follows:

1. Subject of the contract.

The Parties undertake to organize the practice of students on the terms and conditions stipulated by this Agreement.

2. Obligations of the parties.

2.1. The Institute shall:

- Appoint qualified specialists from among the teachers of graduating departments to guide practice
- Prior to the start of practice, provide a situation, a program of practice, inform about the timing of the practice and lists of students undergoing practice
- Send students to the medical organization on time, according to the schedule
- Take part in the investigation by the commission of accidents that occurred with students in accordance with the labor legislation of the Kyrgyz Republic
- Accept from among the experienced employees of the medical organization, part-time teachers, as heads of practice from enterprises and pay according to existing regulatory documents
- Provide the employees of the medical organization with the opportunity to use the scientific library, take part in research and other works.

2.2 The medical organization shall:

- Provide 15 seats for students to practice
- Create the necessary conditions for students to complete practice programs
- Prevent the use of trainees in work unintended by the practice program during practice
- Appoint qualified professionals and practice managers who monitor the progress of the practice in accordance with the program, assist students in the selection of the necessary materials for individual tasks
- Ensure high-quality general instruction on safety rules, with preparation of established documentation
- Provide students with protective clothing, special shoes and personal protective equipment if necessary
- Provide trainees with the opportunity to use the literature, equipment and medical documentation available in the medical organization


- Check the reports of trainees, to give a description of the student's production activities during the practice
- Monitor compliance of students with internal regulations and labor discipline
- Notify the Institution of all cases of violations, as appropriate.

Agreement Terms

This Agreement is made in two copies and is effective from the moment of signing by both parties. The term of the Agreement is 5 years.


