Educational institution of higher professional education "Research Medical and Social Institute", hereinafter referred to as the Institute, represented by the rector of Tampagarov Kushtarbek Bekmuratovich, on the one hand, and the "

Clinical Hospital", hereinafter referred to as the Organization represented by the

director Dr. Abdullah. Gulnawala.

, - acting on the basis of the Charter, hereinafter collectively referred to as the "Parties", and separately the "Party", have entered into this agreement on the following:

1. The Subject of the Agreement.

The parties undertake obligations to organize the practice of students on the terms stipulated by this agreement.

2. Obligations of the parties.

2.1. The Institute undertakes:

Appoint qualified specialists from among the teachers of the graduating departments to guide the practice;

Before the start of the internship, provide the position, the internship program, inform about the terms of the internship and the lists of students undergoing internship;

Send students to the medical organization on time, according to the schedule;

Participate in the investigation by the commission of accidents that happened to students in accordance with the labor legislation of the Kyrgyz Republic;

To accept from the number of experienced workers of a medical organization, part-time teachers, as leaders of practice from enterprises and pay in accordance with existing regulatory documents;

Provide the employees of the medical organization with the opportunity to use the scientific library, take part in research and other work.

2.2 The medical organization undertakes:

Provide 100 places for students to practice;

To create the necessary conditions for students to complete internship programs. Do not allow during the practice the use of student-trainees in jobs not foreseen by the practice program;

Appoint qualified specialists of practice leaders who control the passage of practice in accordance with the program, assist students in the selection of the

necessary materials to complete individual assignments;

Ensure a high-quality general briefing on safety regulations, with the execution of the established documentation;

Provide students, if necessary, with protective clothing, special footwear and personal protective equipment;

Provide student trainees with the opportunity to use the literature, equipment and medical documentation available in the medical organization;

Check the reports of trainees, give a characteristic about the student's production activity during the practice;


Monitor the students' compliance with the internal regulations and labor discipline; if necessary, notify the institute of all cases of violations.

Agreement conditions

The agreement has been drawn up in duplicate. It comes into force from the moment of signing by both parties. The contract is valid for 5 years.
